

Plan of Action – Step by Step – for contact by an agent

1. Have in place the ability to record phone calls and visits from any perpetrators using the Corona-scandal to restrict your natural rights.
2. Have several Criminal Trespass Warnings all filled out with your data, so that all you have to do is add in the agent's name and hand it to them.
3. Have the Legal Basis for Mask letter, along with the Mask Cover letter, ready to hand to any agent.
4. **If called:**
 - A. **Let your voicemail answer the call, but respond to them by email if possible.**
 - B. **If you choose to speak with them by phone, it is legal and lawful in New York State, for you to record the call without informing the person you are speaking with.**
5. **If visited in person, initiate recording - first thing!**
 - A. **Ask the visitors for their proper name.**
 - B. **Ask them for their supervisors' name.**
 - C. **Ask them if they are a 'Public Officer'.**
 - D. **Enter their name into the top left of a Criminal Trespass Warning, that you already have completed. Hand it to them and inform them that they are trespassing and must leave immediately. If they persist, call 9-1-1 so there is a formal public record of their unlawful entry. After the event has concluded, MAKE SURE you file a complaint with their department or agency. This is ESSENTIAL. Obtain the complaint form by calling the office of the agency involved. Do not ignore this VERY IMPORTANT FOLLOW UP. If we do not file complaints, this will continue happening.**

Questions you may choose to ask during phone calls or visits by agents.

- A. During any conversations try not to make statements, but rather ask questions such as:
 - "Who are you?"*** IF they announce their agency rather than their name, ask them ***"Is that what appears on their birth certificate?"***
 - "Do you have a warrant signed by a judge?"***
 - "Can you show me the Constitutional Authority you're exercising?"***
 - "Can you show me the law you're asking me to follow?"*** If they show you the Governor's executive order about masks or limits on gathering, you can reply, ***"Are you aware that order violates the Constitutions of both NYS and the US? And are you aware, as such, that the order is null and void, and not enforceable?"***
 - "Do you realize you can be held personally liable for all the actions you're taking today, for all damages caused to me, my family and my business?"***
 - "Do you realize that my time is valuable, and I'll be billing you \$100 per minute?"***
 - "Are you forcing me into a contract with you?"***
 - If they say, ***"what?"*** – you can say ***"If you're not charging me with a criminal action, then we must be under Civil Commercial Law, correct?"***
 - If they are armed, ***"I see you are armed. Are you compelling me to perform under force?"***

If you are served with a fine, you can require a hearing in court by filing an Article 78 at the court clerk's office. This will get you a hearing in front of a judge at which you can make your case.
